No. <u>13865</u> /F-I In pursuance of approval of Chief Minister Punjab and concurrence of Finance Department Government of the Punjab, sanction is hereby accorded to the following:

- i) Risk Allowance, being drawn by the officers/officials of Punjab Police, is abolished with effect from 30.06.2017.
- ii) A new allowance titled as "Police Law and Order Allowance", at the rate of Risk Allowance as on 30.06.2017, is granted with effect from 01.07.2017 to the officers/officials of Punjab Police.
- iii) Fixed Daily Allowance (FDA), as was admissible on 30.06.2017, will continue on the same rates with effect from 01.07.2017.

 The above allowances will not be admissible to the following officers/officials:
- i) Under suspension.
- ii) Who have been made OSDs on the charge of inefficiency/misconduct or indiscipline.
- iii) Who have been directed to report to Police Lines/Police Headquarters/S&GAD for inefficiency/misconduct/indiscipline on poor performance of duties.
- iv) When officer/official is on leave for four months or more, extraordinary leave, study leave or training (local/abroad).
- v) Who are not working in the Police Department.
- Vi) Who are waiting for posting other than those already mentioned above.

 The "Police Law and Order Allowance" will not be admissible to the employees.
- 3. The "Police Law and Order Allowance" will not be admissible to the employees of City Traffic Police (CTP) and Punjab Highway Patrol (PHP).
- 4. The Punjab Police shall meet the expenditures involved from its existing budgetary allocation for the year 2017-18.
