TERMS & CONDITIONS TO PARTICIPATE IN TENDER (FRAME WORK CONTRACT).

1. Each bid shall comprise a single sealed package containing two separate envelopes as under:-

i.) TECHNICAL PROPOSAL: Detail of specifications, make country etc. On the firms letter head pad along with catalogue, bidding documents, earnest money for respective item.

ii.) FINANCIAL PROPOSAL: Rate of respective item including all taxes/charges whatsoever, as per following form on the Firms letter head pad:-

The envelope should be marked in bold letters has "Technical proposal" and "Financial proposal" respectively with name of items:-

DO NOT INCLUDE FINANCIAL PROPOSAL INSIDE TECHNICAL PROPOSAL ENVELOP OR ANY STATEMENT IN TECHNICAL PROPOSAL ENVELOP OR ANY STATEMENT IN TECHNICAL PROPOSAL WHICH MAY INDICATE YOUR PRICE.

1. The last date of tender submission is 14.01.2021 at 11.00 am and will be opened on the same date at 11.30 am.
2. Only Technical proposal will be opened in the presence of bidders while Financial proposal shall remain (in sealed form) in the custody of the Committee and would be opened after Technical evaluation. The financial proposal of those firms will open who will be technically qualified. The Financial proposal of technically rejected firms would be returned un-opened at the time of financial opening to the respective bidders.
3. The bidders shall submit original earnest money @3% with their technical proposal of the estimated cost of each lot items in the shape of pay order/Bank draft of any Scheduled Bank in favor of the AIG/Logistics, Punjab, CPO, Lahore. Earnest Money less than 3% of estimated cost of Police department will lead to non-responsive and disqualification. In case of non-acceptance of tender earnest money will be refunded after Finalization of the tender. No copy with Technical Proposal will be entertained at any cost.
4. In case of acceptance of tender, bidders shall deposit a security @10% of the total value of frame work contract, in the Form of deposit at call in the name of AIG/Logistics, Punjab, CPO, Lahore and draw the contract agreement. Security shall be refunded on successful completion of the contract or 30.06.2021 whichever is earlier.
5. Rates quoted would be considered inclusive of all taxes/duties/charges and valid up to 30.06.2021.
