Instructions to be considered while recruitment of legal heirs of shaheed;

Only one person shall be recruited, subject to fulfilling criteria of qualification of

the candidate. Child or spouse of Shaheed Police personnel having ranks from Constable to Sub-Inspector level may be paralled as Junior Clerk (RPS-7), Constable, Driver

Constable, Wireless Operator (BPS-5) or Menial Staff (BPS:1-5). Child or snouse of Shaheed Police Personnel having ranks from Inspector and above shall be recruited as Sub-Inspector, subject to qualification and other required criteria.

The recruitment shall be strictly made conditional to fulfilling criteria of

qualification of the said post. Education:- Rule 14, which shall read as follows:

"The children of Shaheed Police Personnel would be "No changes" provided free education from Primary to Post Graduate level and all expenses in this context shall be borne by the Punish Government. The IGP/PPO shall collect details of all expenditures incurred on the education of the children of the Shaheed Police Personnel and would submit the actual
