**BLACKLISTING OF M/S RAB NAWAZ & CO. FOR A  
PERIOD OF ONE YEAR W.E.F 01.04.2022**

It is intimated that after affording personal hearing and perusing the available record by the committee constituted by this office including your reply of Show Cause Notice, the competent authority has found that the representative concealed the facts intentionally that the firm has already been blacklisted on the recommendation of Lahore High Court, Bahawalpur Bench, Bahawalpur vide order No. 369/Genl, dated 25.03.2021 for one year. The report of FBR Multan received vide Memo No. CCIR/SO-ST/F-31/2021-22/13051, dated 18.03.2022, regarding the clarification whether the firm is same or otherwise, is reproduced below:-

"It has been reported by the Commissioner Multan Zone that Malik Rab Nawaz having CNIC:36302-8497717-9 is proprietor of two units namely:  
i. M/S Rab Nawaz & Company bearing NTN:2455821-4/STRN:0400999911237 registered as an individual.  
ii. M/S Rab Nawaz & Company bearing NTN:7124935-4/STRN:3277876114690 registered as an association of person (Firm)".

2. Having heard and perusing the record for the aforesaid reasons, the committee is of the view that the firm participated in the tender process 2021-22 of this office is same firm who had earlier blacklisted in year 2021 by the Honorable Lahore High Court, Bahawalpur Bench, Bahawalpur.

3. The representative of the firm also submitted affidavits against the facts, intentionally deceived this office by not showing the facts. It is established fact that M/S Rab Nawaz & Co. entered the process with dubious and fraudulent intent and acted in a manner determinantal to the good business practices. All this renders this company liable to be blacklisted and debarred from participating in any public procurement process for a period of one year

w.e.f 01<sup>st</sup> April 2022 as envisaged by rule 21 of the PPRA Rules. Accordingly M/S Rab Nawaz & Co. having NTN:2455821-4/STRN:0400999911237 and NTN:7124935-4/STRN:3277876114690 is blacklisted and debarred from participating in any procurement process for the period of one year w.e.f 01<sup>st</sup> April 2022. Copy of the order is being provided to you as per requirement of clause 09 of the Schedule of Punjab Procurement Rules, 2014 to make representation to appropriate forum.
