

Outlined below are the procedures to be followed by Permanent Missions for the presentation of candidates for assignment as members of the Investigative team in Iraq to support domestic efforts to hold Da'esh/ISIL accountable by collecting, preserving and storing evidence of acts that may have amounted to war crimes, crimes against humanity and genocide.

The above-mentioned posts are reserved for candidates recommended by Member States through their Permanent Missions to the United Nations. Candidates applying independently will not be considered. It is requested that applications be submitted as soon as possible but not later than deadline specified in each Job Opening announcement. Applications received after the deadline will not be considered.

- 1. All applications must be submitted on a duly completed (typed) and signed United Nations Electronic Application for Seconded Police (EASP) form. For any other government officer other than a Police officer, an additional Curriculum Vitae on a standard format may be attached to the EASP form. For the convenience of the Permanent Missions, an EASP form is enclosed as a sample and shall be used for applications for the seconded non-contracted posts only.



Demonstrated ability and skills in working with people of different ethnic and cultural backgrounds, and expertise in the use of interpreters. Willingness to work flexible hours and attend meetings or to witness needs outside normal working hours. Willingness to provide assistance to all witnesses. Shows pride in work and achievements; demonstrates professional competence and mastery of subject matter; is conscientious and efficient in meeting commitments, observing deadlines and achieving results; is motivated by professionalism rather than personal concerns; shows persistence when faced with difficult problems or challenges; remains calm in stressful situations; takes responsibility for incorporating gender perspectives and ensuring the equal participation of women and men in all areas of work.

Planning& Organizing: Develops clear goals that are consistent with agreed strategies; identifies priority activities and assignments; adjusts priorities as required; allocates appropriate amount of time and resources for completing work; foresees risks and allows for contingencies when planning; monitors and adjusts plans and actions as necessary; uses time efficiently.

Client Orientation: Considers all those to whom services are provided to be "clients" and seeks to see things from clients' point of view; establishes and maintains productive partnerships with clients by gaining their trust and respect; identifies clients' needs and matches them to appropriate solutions; monitors ongoing developments inside and outside the clients' environment to keep informed and anticipate problems; keeps clients informed of progress or setbacks in projects; meets timeline for delivery of products or services to client.

#### Education

Advanced university degree (Master's degree or equivalent) in law, political science, international relations, risk management or other relevant area is required. A first-level university degree in combination with qualifying experience may be accepted in lieu of the advanced university degree.

#### Work Experience

A minimum of five years of progressively responsible professional experience in witness protection related activities within court or law enforcement structures is required. Minimum of three years of full-time work experience preferably in a national or in international witness protection programme is required.

Experience in delivering training and capacity building on issues relating to witness protection in domestic or international setting is desirable.

Experience in conducting threat and risk assessments for witnesses is desirable.

Work experience in a conflict or post conflict context is an asset.

Experience in Middle East especially in witness protection related capacity is desirable. Languages

English and French are the working languages of the United Nations Secretariat. For the position advertised, fluency in English is required. Knowledge of Arabic and/or Kurdish is desirable.

# Assessment for Mission Service:

Evaluation of qualified candidates may include an assessment exercise which will be followed by competency-based interview.

Selected candidates shall be subjected to driving and vehicle handling skills in the mission area. Failure to pass this assessment may result to repatriation. All repatriation related expenses in this case are to be borne by the Member State.
