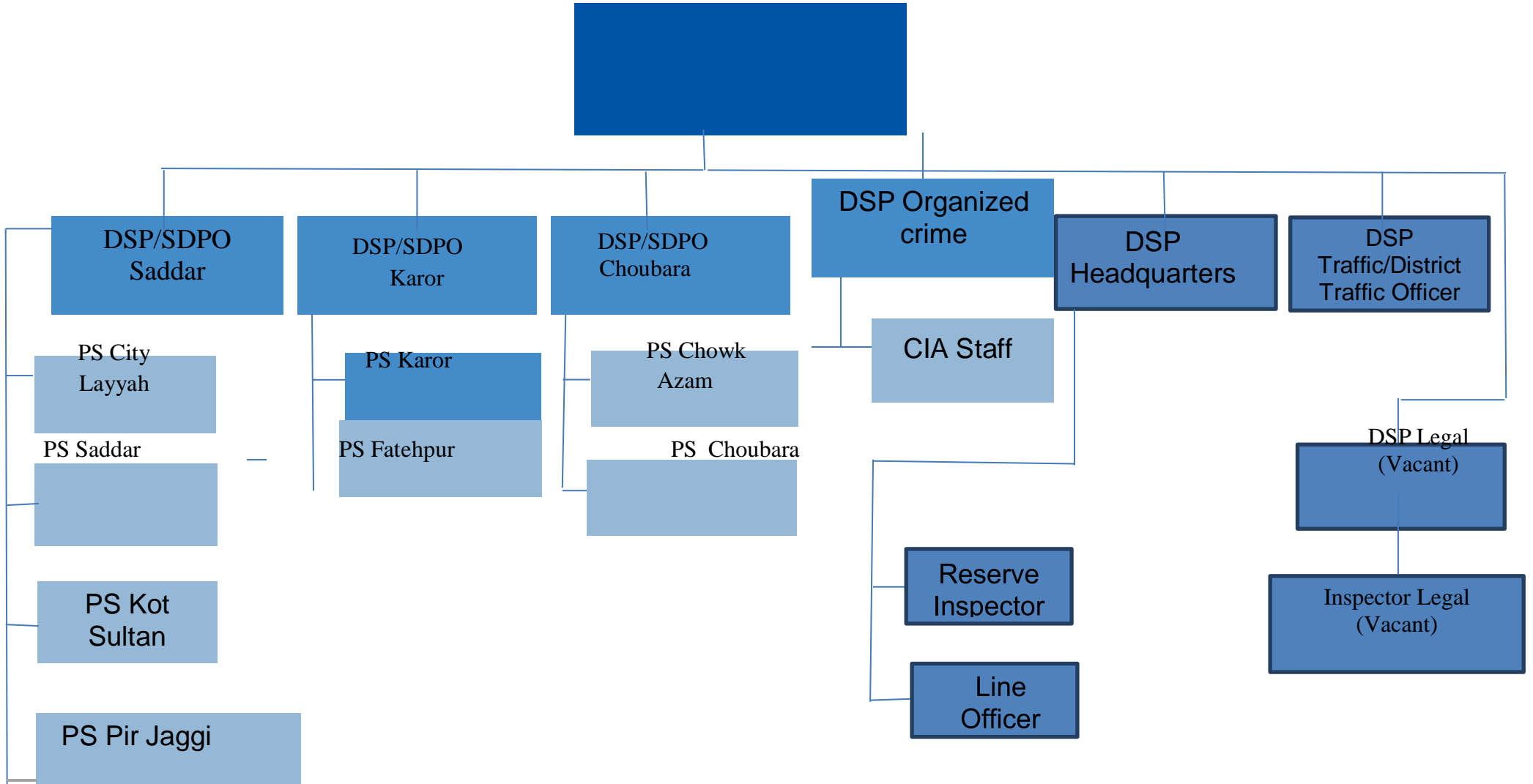

## DISTRICT DETAIL

Layyah is one of the peaceful districts in South Punjab which is located at 30°45' to 31°24' north latitude and 70°44' to 71°50' east longitude. This district is bounded by Districts Bhakkar, Muzaffar Garh and Jhang whereas Indus River separates this district from Dera Ghazi Khan on the western side. The map of the district is also given below. Layyah covers the area of 6291 square kilometers. The area covered by District Layyah is approximately 3% of total area of Punjab while 0.8% of total area of Pakistan. Areas covered by Tehsils of the district is given in the table below,

### Population:

According to the census 2017, the total population of the district is 1.824 million.<sup>1</sup> While according to census 1998, the total population of the district was 1.120 million which grew with the growth rate of 3.10%. The major portion of the population is living in the rural areas. The proportion of urban and rural population is 12.86% and 87.14% respectively.

### Area of the District:
