

## **POLICE TRAINING COLLEGE, LAHORE.** **TENDER NOTICE**

Police Training College, Lahore, invites sealed tenders based on the Punjab Procurement Rules 2014, for the procurement of the following items on FOR basis from well-reputed and financially sound firms having previous experience as well as registered with Income Tax and Sales Tax Department. Bids are to be addressed to the DIG/Commandant, Police Training College, Lahore and shall be received till **10.01.2018 (Wednesday) before 10.30 a.m. and shall be opened at 11.00 a.m. on the same day.** in Police Training College, Lahore. The samples required at the time of opening tenders for technical evaluation are noted against each item:-

2. The bids shall be received under "Single Stage – Two Envelopes bidding procedure" as contained in rule 38 (2) (a) of the Punjab Procurement Rules 2014. The bids shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the 'Financial Proposal' and the 'Technical Proposal'. Rates quoted would be considered only if the same are in Pak rupees and inclusive of all taxes/duties/charges and inclusive of packing/freight till delivery at Police Training College, Lahore. The rates quoted shall be valid upto 30.06.2018.

3. Initially, the Technical Proposals will be opened on 10.01.2018 (Wednesday) at 11.00 a.m. in the presence of bidders or their representatives, while the Financial Proposals shall remain (in sealed form) in the custody of the College authority and would be opened after receipt of the technical evaluation report, in the presence of qualified bidders. The technically qualified bids having lowest cost would be accepted. The financial proposals of bids found un-acceptable shall be returned un-opened to the respective bidders under the rules.

4. The bidding documents containing terms & conditions, standard specifications of respective item etc. are immediately available and can be obtained after the publication or uploading of tender on PPRA's website from the office of the DIG/Commandant, Police Training College, Lahore, by hand on submission of a written request on firm's letter head, on any working day during office hours, a day before the bids opening at the cost of Rs.500/- for each item duly deposited in the State Bank of Pakistan on Treasury Challan Form 32-A, under "Head of Account CO2636-Police Fees, Fines & Forfeiture"

5. The bidders shall submit bid security @ 3% of the estimated price with their Technical Proposals in shape of Pay Order or Bank Draft of any scheduled bank in favour of the DIG/Commandant, Police Training College, Lahore. The bid security will be refunded after finalization of the tenders. However, the successful bidders shall deposit equal to 5% of the total value of the contract as performance guarantee which shall be refunded on successful completion of the contract. The delivery time of stores would be 15 days.

6. The authority reserves the right to reject all bids or proposals in line with Rule 35 of PPRA Rules 2014. In case of public holiday due to reason, the date of receiving and opening the tenders will be next working day.
