Technical Compliance of the Bidders to the Employer's Requirements

**Technical Bid Evaluation Report
June 2016**

I, Gottfried Reiter, Foreign Expert, (the Consultant) have been engaged by National Engineering Services Pakistan (Pvt.) Limited (NESPAK) to provide consultancy services for the subject procurement. As a part of my services, I have performed the task, viz., Evaluation of the Technical Bids, submitted by the two Bidders (M/s Volkan and M/s Katmerciler). The procurement process is based upon Single Stage-Two Envelopes Bidding procedure.

Technical Bids of the two Bidders were sent to me on May 18, 2016 and evaluation of the Bidders' offered vehicle was started immediately w.r.t their compliance with the Technical Specifications as mentioned in the Bidding Documents.

After initial scrutiny of the data furnished by the Bidders, Compliance Statement Report was prepared by the Consultant and submitted on May 30, 2016.


It was noted that M/s Volkan submitted the Technical Bids precisely responding to the Technical Specification. However, some Post-Bid Clarifications were asked to the Bidder for the purpose of further clarity through Punjab Police Department.

On the other hand, M/s Katmerciler submitted his Technical Bid that did not clearly mention features and facts about their offered vehicle against the Technical Specifications. Numerous queries were raised and so many remarks were given on M/s Katmerciler Technical Bid. Accordingly, Post-Bid Clarifications were asked to the Bidder for the purpose of the clarity through Punjab Police Department, for providing equal opportunity to compete in procurement process.

It is pertinent to mention that Post-Bid Clarifications have been enquired from both the Bidders by Punjab Police Department two times.

M/s Volkan has submitted his response to the Post-Bid Clarification on June 02, 2016 and thereafter June 15, 2016. It has been noted that M/s Volkan has complied with all queries positively except two minor issues narrated below, which are required to be done prior to signing of the Contract, if finally awarded to him:

- a) Water Tank content in axle weight calculation is not correct. Weight calculations may be discussed prior to award of the Contract ; and



- b) Mounting location and method for rubber cone bearings (first front and last rear), to be discussed prior to award of the Contract.

Compliance Statement Report on M/s Volkan Technical Bid is attached in Annex A1 and Annex A2.

M/s Katmerciler has submitted his response to the Post-Bid Clarification on June 07, 2016 and thereafter June 14, 2016. It has been noted that M/s Katmerciler has not complied with the queries made through Post-Bid Clarification. In fact he has re-submitted general information without any specific reference to any particular section of such document, w.r.t the Post-Bid Clarifications. Some major pending technical issues pertaining to M/s Katmerciler Technical Bid are narrated hereunder:

- a) Water Pump output;
- b) Roof monitor performance;
- c) Operation weight and weight distribution;
- d) Camera specifications are not clear; and
- e) Real time recorder (recording capacity issue).
- f) Other, yellow marked queries, shown in Annex B1.
- g) Queries and remarks, in red letters, shown in Annex-B2.

It is, therefore, inferred that M/s Katmerciler Technical Bid and data received in response of Post-Bid Clarifications do not show conformance with Technical Specifications as mentioned in Bidding Documents.

Compliance Statement Report on M/s Katmerciler Technical Bid is attached as Annex-B1 and Annex-B2.

Based upon information/data gathered so far, M/s Volkan is found technically responsive bidder for the subject procurement.
