

BIDDING DOCUMENTS

Terms & Conditions to participate in Tender Of Repair/Maintenance and Replacement of parts of three (03) nos. Lift and (03) Nos. Generator 100 KVA,250KVA and 750KVA installed at CPO Punjab (list enclosed) for CPO Complex, Lahore.

1. Punjab Police Department invites sealed tenders/bids/proposals based on the Punjab Procurement Rules 2014, from well reputed firms, registered with Income Tax and Sales Tax Departments and Punjab Revenue Authority, for Repair/Maintenance and replacement of parts of three (03) nos. Lift and (03) Nos. Generator 100 KVA,250KVA and 750KVA installed at CPO Punjab (list enclosed) for CPO Complex, Lahore.
Each bid shall comprise a single sealed package containing two separate envelopes as under:-

1). TECHNICAL PROPOSAL: Containing detail of items etc. on the firm's letter head pad along-with bidding documents, bid security for respective item.

2). FINANCIAL PROPOSAL: Rate of respective item including all taxes/ charges whatsoever, as per following form on the Firm's letter Head Pad:-

The envelopes should be marked in bold letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively with name of item.

- **DO NOT INCLUDE FINANCIAL PROPOSAL INSIDE TECHNICAL PROPOSAL ENVELOPE OR ANY STATEMENT IN TECHNICAL PROPOSAL WHICH MAY INDICATE YOUR PRICES.**

2. Technical & Financial proposals will be received in this office on **06.10.2022** before **11.00A.M** and shall be opened on the same day at **11.30A.M as per Single Stage Single Envelope Procedure**. Technically qualified & lowest bid would be accepted. Technical qualified criteria is enclosed.
3. The bidders shall submit Earnest Money @ **3%** of estimated price with their Technical proposal of the total value of their tender items in the shape of Pay Orders/Bank Drafts/Call Deposit Receipt of any Scheduled Bank in favour of the AIG Logistics CPO Lahore. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of the tender.
4. In case of acceptance of tenders, bidders shall deposit "performance guarantee @10% of the total value of repair/maintenance in the form of Pay Order/Bank Draft/Call Deposit Receipt of any Scheduled Bank in the name of AIG/Logistics, CPO, Lahore, Security shall be refunded on successful completion of the contract.
5. Rates quoted would be considered inclusive of all taxes/duties/charges and shall be valid up-to **30.06.2023**.
6. The authority reserves the right to reject all bids or proposals in line with Rule 35 of Punjab Procurement Rules, 2014. The provisions of PPRA2014 2014 must be followed in true letter and spirit.
7. In case, repair/replacement found not according to the standard approved sample specifications, same will be rejected at the cost of the contractor and may also result in forfeiture of security and blacklisting the firm. However, the store may be accepted if the offered repair/replacement has higher/better specification that the standard specific.
8. The Bidding application which is received after the closing date and time shall not be entertained.

BIDDING EVALUATION CRITERIA FOR REPAIR/MAINTENANCE AND REPLACEMENT OF PARTS OF THREE (03) NOS. LIFT AND (03) NOS. GENERATOR 100 KVA, 250 KVA AND 750KVA INSTALLED AT CPO PUNJAB FOR CPO COMPLEX, LAHORE.

Bidding will be based on applicant fulfilling the following qualification criteria:

i) Registration with Income Tax Authorities (National Tax Number NTN) at least three years old (Issued till July 2018)		
ii) Copy of Registration with Sales Tax Authorities (STRN)		
iii) Copy of Registration (Professional Tax Certificate)		
iv) Affidavit on non-judicial Stamp Paper of Rs. 100 (i) The firm has not been black listed from any Department. (ii) The documents/photocopies provided with bid are authentic. In case of any fake/bogus document look at any stage. The firm shall be black listed as per Rules/Laws. (iii) Affidavit for correctness of information. (iv) Contractor/firm is not blacklisted or subject to any pending litigation with any Government or Public Department.		
v) Vendor Number with proposal/bid		
vi) Original Bid Security 3% of quarterly allotted funds by the Government.		


The firm/dealer would not be considered qualified provided the mandatory checklist is not provided.
